The kit's minimum and maximum DNA input requirements are used to make libraries that are sequenced on the same Illumina® flow cell. Library assessment is based on metrics including library yields, GC bias, insert size, and the percent 5mC/5hmC detected for CpG, CHG, CHH contexts within the genomic DNA and internal controls.	Pass
