

Exonuclease Activity (Radioactivity Release) - A 50 μ l reaction in CutSmart TM Buffer containing 1 μ g of a mixture of single and double-stranded [3 H] <i>E. coli</i> DNA and a minimum of 100 units of EcoRV-HF TM incubated for 4 hours at 37°C releases <0.1% of the total radioactivity.	Pass
Ligation and Recutting (Terminal Integrity) - After a 10-fold over-digestion of Lambda DNA with EcoRV-HF TM , >95% of the DNA fragments can be ligated with T4 DNA ligase in 16 hours at 16°C. Of these ligated fragments, >95% can be recut with EcoRV-HF TM .	Pass
