Assay Name/Specification (minimum release criteria)

Endonuclease Activity (Nicking) - A 50  $\mu$ l reaction in rCutSmart<sup>TM</sup> Buffer containing 1  $\mu$ g of supercoiled PhiX174 DNA and a minimum of 5 units of SnaBI incubated for 4 hours at 37°C results in <20% conversion to the nicked form as determined by agarose gel electrophoresis.

**Exonuclease Activity (Radioactivity Release)** - A 50  $\mu$ l reaction in rCutSmart<sup>TM</sup> Buffer containing 1  $\mu$ g of a mixture of single and double-stranded [<sup>3</sup>H] *E. coli* DNA and a minimum of 50 units of SnaBI incubated for 4 hours at 37°C releases <0.1% of the total radioactivity.

**Ligation and Recutting (Terminal Integrity)** - After a 20-fold over-digestion of T7 DNA with SnaBI, >95% of the DNA fragments can be ligated with T4 DNA ligase in 16 hours at 16°C. Of these ligated fragments, >95% can be recut with SnaBI.

Non-Specific DNase Activity (16 Hour) - A 50  $\mu$ l reaction in rCutSmart<sup>TM</sup> Buffer containing 1  $\mu$ g of T7 DNA and a minimum of 5 units of SnaBI incubated for 16 hours at 37°C results in a DNA pattern free of detectable nuclease degradation as determined by agarose gel electrophoresis.

Protein Purity Assay (SDS-PAGE) - SnaBI is ≥ 95% pure as determined by SDS-PAGE analysis using Coomassie Blue detection.

**qPCR DNA Contamination** (*E. coli* Genomic) - A minimum of 5 units of SnaBI is screened for the presence of *E. coli* genomic DNA using SYBR® Green qPCR with primers specific for the *E. coli* 16S rRNA locus. Results are quantified using a standard curve generated from purified *E. coli* genomic DNA. The measured level of *E. coli* genomic DNA contamination is  $\leq 1$  *E. coli* genome.
