Endonuclease Activity (Nicking) - A 50 μ l reaction in CutSmartTM Buffer containing 1 μ g of supercoiled Litmus 38 iDNA and a minimum of 60 Units of XmnI incubated for 4 hours at 37°C results in <10% conversion to the nicked form as determined by agarose gel electrophoresis.
