Assay Name/Specification (minimum release criteria)

Blue-White Screening (Terminal Integrity) - A sample of pUC19 vector linearized with a 10-fold excess of EcoRI-HF®, religated and transformed into an *E. coli* strain expressing the LacZ beta fragment gene results in <1% white colonies.

Endonuclease Activity (Nicking) - A 50 μ l reaction in rCutSmartTM Buffer containing 1 μ g of supercoiled PhiX174 DNA and a minimum of 100 units of EcoRI-HF® incubated for 4 hours at 37°C results in <10% conversion to the nicked form as determined by agarose gel electrophoresis.

Exonuclease Activity (Radioactivity Release) - A 50 μ l reaction in rCutSmartTM Buffer containing 1 μ g of a mixture of single and double-stranded [³H] *E. coli* DNA and a minimum of 200 units of EcoRI-HF® incubated for 4 hours at 37°C releases <0.1% of the total radioactivity.

Functional Testing (15 minute Digest) - A 50 μ l reaction in rCutSmartTM Buffer containing 1 μ g of Lambda DNA and 1 μ l of EcoRI-HF® incubated for 15 minutes at 37°C results in complete digestion as determined by agarose gel electrophoresis.

Ligation and Recutting (Terminal Integrity) - After a 20-fold over-digestion of Lambda DNA with EcoRI-HF®, >95% of the DNA fragments can be ligated with T4 DNA ligase in 16 hours at 16°C. Of these ligated fragments, >95% can be recut with EcoRI-HF®.

Non-Specific DNase Activity (16 Hour) - A 50 µl reaction in rCutSmartTM Buffer containing 1 µg of Lambda DNA and a minimum of 100 units of EcoRI-HF® incubated for 16 hours at 37°C results in a DNA pattern free of detectable nuclease degradation as determined by agarose gel electrophoresis.

Protein Purity Assay (SDS-PAGE) - EcoRI-HF® is >95% pure as determined by SDS PAGE analysis using Coomassie Blue detection.

Assay Name/Specification (minimum release criteria)

qPCR DNA Contamination (*E. coli* **Genomic)** - A minimum of 20 units of EcoRI-HF® is screened for the presence of *E. coli* **genomic** DNA using SYBR® Green qPCR with primers specific for the *E. coli* 16S rRNA locus. Results are quantified using a standard curve generated from purified *E. coli* genomic DNA. The measured level of *E. coli* genomic DNA contamination is ≤ 1 *E. coli* genome.

RNase Activity (Extended Digestion) - A 10 μ l reaction in NEBuffer 4 containing 40 ng of a 300 base single-stranded RNA and a minimum of 20 units of EcoRI-HF® is incubated at 37°C. After incubation for 4 hours, >90% of the substrate RNA remains intact as determined by gel electrophoresis using fluorescent detection.
