Assay Name/Specification (minimum release criteria)

Blue-White Screening (Terminal Integrity) - A sample of pUC19 vector linearized with a 10-fold excess of EcoRI, religated and transformed into an *E. coli* strain expressing the LacZ beta fragment gene results in <1% white colonies.

Exonuclease Activity (Radioactivity Release) - A 50 µl reaction in 1X NEBuffer EcoRI/SspI containing 1 µg of a mixture of single and double-stranded [³H] *E. coli* DNA and a minimum of 200 units of EcoRI incubated for 4 hours at 37°C releases <0.1% of the total radioactivity.

Ligation and Recutting (Terminal Integrity) - After a 20-fold over-digestion of Lambda DNA with EcoRI, >95% of the DNA fragments can be ligated with T4 DNA ligase in 16 hours at 16°C. Of these ligated fragments, >95% can be recut with EcoRI.

Non-Specific DNase Activity (16 Hour) - A 50 µl reaction in 1X NEBuffer EcoRI/SspI containing 1 µg of Lambda DNA and a minimum of 100 units of EcoRI incubated for 16 hours at 37°C results in a DNA pattern free of detectable nuclease degradation as determined by agarose gel electrophoresis.

Protein Purity Assay (SDS-PAGE) - EcoRI is >95% pure as determined by SDS PAGE analysis using Coomassie Blue detection.

qPCR DNA Contamination (*E. coli* Genomic) - A minimum of 20 units of EcoRI is screened for the presence of *E. coli* genomic DNA using SYBR® Green qPCR with primers specific for the *E. coli* 16S rRNA locus. Results are quantified using a standard curve generated from purified *E. coli* genomic DNA. The measured level of *E. coli* genomic DNA contamination is ≤ 1 *E. coli* genome.
